WSSA's first conference in Canada was one of the best Annual Conferences in recent memory. Although attendance was down from previous years, the sessions were full and we saw a lot of new faces. Some people under-estimated the length of time it would take to obtain their passports and several pulled out at the last moment.

Over 800 papers were pre-

sented and the Association for Borderlands Studies (ABS) which celebrated its 30th Anniversary, had the largest number of participants. ABS had 28 Panels and Canadian Studies had 21. The Rural Studies Section had 13 Panels and the Section Coordinator commented that this was the best conference for Rural Studies that he could remember. Dealing With Rejection: A Quick Guide On What To Do When An Academic Journal Turns Down Your Paper

Since becoming the Editor of the SOCIAL SCIENCE JOURNAL (SSJ, official journal of the WSSA) two years ago, I have received and dealt with roughly 180 articles and research notes. The majority, around two-thirds of the submissions, have been rejected. This should not come as a surprise. If you have been in academe long enough you know that there is a good likelihood that the papers you write, in meeting the expectation to do research and publish, are going to be rejected. Much like performers answering “cattle calls” for upcoming productions who hear the dreaded words, “Thank you, we will let you know” only to be never called back, the communication from the Editor of the journal expressing regret for rejecting your a paper is a staple of academic life. Having received my share of them over the years, and now being in a position of having to write rejections to authors who have submitted papers to SSJ, here are a few pieces of advice that may be of help to you in dealing with the aftermath.

1. Determine if the paper has been rejected internally or after being sent out for review. Most Editors look at submissions soon after receiving them with an eye towards deciding if they are “right” for their journal. While SSJ has a broad mandate in that we cover the entire gamut of the social sciences, we sometimes get papers that *prima facie* are not appropriate for us. For example, papers that are theological as opposed to the scientific study of religion or about product design as opposed to human involvement in or social implications of production are better off being sent to outlets other than SSJ. Papers deemed “inappropriate” trigger an internal rejection, which you will hear about fairly quickly. Your task now becomes finding a journal where your paper will fit better.

Papers being rejected after being sent to external reviewers obligate you to read and respond to the comments made by them and the Editor. Although it has been rejected by one journal, there is no reason why you cannot revise it and send it to another one. [It bears repeating that most academic journals will not allow you to submit your paper to multiple journals simultaneously.]

2. Give yourself some time to read and respond to the comments. After you have got yourself over the initial reactions of hurt and disappointment mixed with anger at the “unfairness” of it all, here are some practical steps to take. Painful as it may be, you should force yourself to read through the comments provided by the reviewers and the Editor’s decision letter. Sometimes (very rarely, if the reviewers have done their work with sincerity) they may have misunderstood your work and your words or worse still, be biased against it. You should talk to your co-authors, if any, and others knowledgeable about the publication process or of your substantive area to make sure they share your reading of the reactions. If it is indeed based on misunderstanding or bias, all you have to do is make more copies of the original paper and send it on its way to another journal.

3. If you and trusted others find merit in the criticisms of the reviewers, reflect on what the reviewers are asking you to do. The American Psychological Association [see <http://www.apa.org/journals/authors/guide.html>] notes that articles are rejected outright for the following substantive or methodological reasons. “Substantive concerns include lack of theoretical grounding, confusing or unclear conceptualization or rationale of the research problem, unspecified relationships between variables, and insignificant contribution to the literature. Serious methodological problems include nonrandom samples, confounded independent variables, invalid or unreliable measures, inappropriate statistical analysis, lack of statistical power, and lack of external validity.” From my observation and knowing that the above list applies mostly to empirical/quantitative articles, no one reason will automatically lead to a rejection; however, a combination of two or more of them improves the odds of rejection. Which of these apply to your paper and what can you do to solve the problem?

4. In revising and making changes to your paper consider the theoretical and substantive problems identified by the Editor and the reviewers. Remember, since they have rejected your paper and told you not to darken their door with this paper again, you are under no obligation

Colorado State University Best Graduate Student Paper Award

The 2007 best student paper competition attracted many high quality papers from graduate students from a variety of academic disciplines. The range of topics covered included globalization, development of urban open space, residential solar thermal use, climate protection campaign, identity politics, political physiopsychology, rural farmers market, impact of city ownership of telecommunications on behavior of cable firms, Japan's nuclear policy, families and bikes, relationship development through on-line phenomenon, Black people's struggle for freedom and equality, Putin's rise to power, and the effect of the Tennessee v. Garner decision.

The paper competition evaluation committee had a difficult decision in selecting the best graduate student paper from several excellent papers. Jeff Novacki's paper, "A Race-Specific Examination of the Effects of the Tennessee v. Garner Decision" received an honorary mention. Jeff is a graduate student in the Department of Sociology at the University of New Mexico.

The recipient of the Best Graduate Student Paper Award was Robert Seamans. The title of his paper is "How Do Laws Restricting City Ownership of Telecommunications Affect Cable Firm Behavior?" The paper uses variations in state laws to explore whether cities can use the threat of entry mechanism as an effective tool to control private cable firm behavior. Jeff presented his award winning paper at the conference under the Economics (Business and Finance) section of the conference.

Robert Seamans is a PhD student in the Department of Business and Public Policy at the Hass School of Business at the University of California at Berkeley. Robert's research focuses on how public agencies shape competitive strategies of private firms. Prior to being a PhD student, Robert worked at Analysis Group and at the Massachusetts Department of Economic Development. Robert holds a MA in economics from Boston University, a MBA from the Yale School of Management, and a BA in English literature from Reed College.

Robert was presented with a check for \$500 and a plaque by Kant Patel, Vice President of the Association at a reception hosted by past presidents and students at the conference.

to respond to everything that they criticized. Revise judiciously and thoughtfully keeping in mind that research in the social sciences is often based on minimal scholarly consensus regarding many issues. Yet at the same time remember that qualified individuals have read your paper and found it wanting. Somehow, in the middle of classes, advising, meetings and conferences, you should find time to revise your paper with a view to fill the gaps exposed in the rejection and in anticipation of winning over the next set of skeptical reviewers. Yes, this is all time consuming. In the meantime, tenure clocks are ticking and promotion application deadlines taunt you. For greater efficiency, divide the task between your co-authors and yourself. After you have completed the revision, ask others to read your revised paper and get their opinion on what you have done.

5. Send your paper to another journal. In the social sciences, we are blessed with a plethora of outlets to which we could send our work. Consider every appropriate possibility: general inter-disciplinary journals (similar to SSJ), disciplinary journals, specialty journals, topical journals, policy and practice journals, etc.
6. If rejected by the second journal, repeat the above process until publication is achieved or academic fatigue sets in. They may not have told you this in graduate school, but your mentors and academic idols have been rejected by journals multiple times.

Good luck and remember that a rejection is not the end of the world. It just means you have to keep trying!
